## 1. General information

Since the last CIML meeting in the Autumn 2021, the most relevant ongoing developments in EURAMET have been:

- The launch of the "European Partnership on Metrology" on 31<sup>st</sup> March 2022 with the signature of the FFPA Financial Framework Partnership Agreement. First projects start since September 2022.
- The organisation of the **EURAMET** "February meetings" (45<sup>th</sup> BoD, 20<sup>th</sup> Joint BoD / TC-C / EMN-C, 21<sup>st</sup> TC-Chairs Workshop and 5<sup>th</sup> EMN-Chairs Workshop) from 15<sup>th</sup> to 17<sup>th</sup> February 2022.
- The organisation of the 16<sup>th</sup> General Assembly, that took place as a hybrid meeting from 30<sup>th</sup> May to 2<sup>nd</sup> June, 2022 in Vienna, Austria. It gathered 118 people involved in metrology activities: EURAMET Delegates, TC and EMN Chairs, BIPM, OIML, RMOs, WELMEC, NCSLi, as well as industrial and research stakeholders.
- The adoption of the **BIPM e-Learning Platform** to promote EURAMET Capacity Building activities and assure knowledge transfer within our metrology community.
- The participation in the BIPM-WMO Metrology for Climate Action Workshop from 26<sup>th</sup> to 30<sup>th</sup> September 2022.
- The progress of specific actions to support the digital transformation of metrology activities in EURAMET: consultations and brainstorm activities to better define trends, needs and priority activities, development of an e-training platform, joint collaborations with institutes from other RMOs and Liaison Organisations, Project on Digital Calibration Certificates, etc.

The most relevant developments related to Legal Metrology were:

• In collaboration with WELMEC (European Cooperation in Legal Metrology entity), EURAMET is actively participating in Legal metrology developments. Since 2020, both associations have tightened the links to further develop synergies among their respective metrology communities. They are currently working on a common European metrology webpage, unified positions on needs and expectations in regulatory aspects, and on digital transformation in metrology topics. Additionally, WELMEC has been very supportive in normative EMPIR research projects.
